MEMORANDUM OF UNDERSTANDING

4. Roles and Responsibilities of the 1st Party are the following:

- I. The students from the 1st party institution shall visit the 2nd party institution and will offer physical and emotional support to their inmates by facilitating their mobility, sharing of knowledge and experience and by other interactions to build rapport and companionship.
- II. The 1st party shall send students batch-wise to attend skill-oriented courses and workshops conducted by the 2nd party.
- III. The 1st party shall not have to pay for the services and training received from the second party.

5. Roles and Responsibilities of the 2nd party are the following:

- I. The 2nd party shall receive the students from the 1st party and will offer them the required hospitality and other facilities.
- II. The 2nd party shall provide resource persons with prepared modules and shall provide infrastructural facilities to conduct such a training programme.
- III. The second party shall issue certificates to students from the first party who complete the course and meet the necessary requirements.
