

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is executed on the 2nd Day of March 2020 between Madeenathul Uloom Arabic College, Pulikkal PO, PIN 673737, Malappuram District as 1st party and Focuz Ayurcentre, Kakkancheri, Malappuram District, Kerala PIN 673634 as 2nd party.

1. The MoU is signed by Dr. Sayyid Muhammed Shakir, Principal, MUA College, Pulikkal on behalf of the 1st party and Dr. Muhammed Mubashir, Medical Director, Focuz Ayurcentre, Kakkancheri on behalf of the 2nd party.
2. The common objective of this MoU is to facilitate a conducive and mutually beneficial environment for social relation and skill learning and thereby to provide exposure to the students in interacting with foreign tourists & to learn the etiquettes of medical tourism management.
3. This MoU is effective from the day of its signing by the authorized representatives of the parties to this MoU and shall remain in force for a period of one year from the date of signing. The MoU may be terminated by either party upon one month's written notice delivered to the other party by hand or by registered mail to the address mentioned above.

Roles and Responsibilities of the 1st Party are the following:

- I. The students from the 1st party institution shall visit the 2nd party institution as and when the second party facilitates such a visit.
- II. The students from the 1st party institution shall accompany the visitors from foreign countries in order to get firsthand experience in communication, etiquettes, cultural aspects and in the art of hospitable treatment of foreign guests.
- III. The students from the first party will undergo a specified period of internship in the second party institution.

Roles and Responsibilities of the 2nd party are the following:

- I. The 2nd party shall receive the students from the 1st party and will offer them the required hospitality and other facilities.
- II. The 2nd party shall give necessary training and orientation to the students from the first party institution in communication, hospitality, cultural aspects and taboos, etiquettes etc.
- III. The second party shall assign apprenticeship to selected and eligible students and will allow them to accompany, interact and to assist the foreigners in their institution.
- IV. The second party shall arrange transportation and other facilities required to students.
- V. The second party shall issue certificates to students from the first party who complete satisfactorily the period of apprenticeship.
