MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is executed on the 3rd Day of February 2021 between Madeenathul Uloom Arabic College, Pulikkal PO, Malappuram District as 1st party and Pulikkal Palliative Care Association, Pulikkal PO, Malappuram District, PIN: 673637 as 2nd party.

1. The MoU is signed by Dr. Sayyid Muhammed Shakir, Principal, MUA College, Pulikkal on behalf of the 1st party and Mr. Najeeb Rahman. M.P, secretary, Pulikkal Palliative Care Association, Pulikkal PO, Malappuram District on behalf of the 2nd party.
2. The common objective of this MOU is to facilitate a conducive and mutually beneficial environment for social extension and social emotional learning and to inculcate a value orientation among the stakeholders of both the institutions.
3. This MoU is effective from the day of its signing by the authorized representatives of the parties to this MoU and shall remain in force for a period of three years from the date of signing. The MoU may be terminated by either party upon one month's written notice delivered to the other party by hand or by registered mail to the address mentioned above.

Roles and Responsibilities of the 1st Party are the following:

- I. The students from the 1st party institution shall visit the 2nd party institution and will offer physical and emotional support to the patients.
- II. The 1st party shall send trained volunteers to assist the 2nd party institution in services such as home care, geriatric care, conducting medical camps etc.

- III. The 1st party shall help the second party to pool resources for the establishment by way of fund raising from students and public, conducting food fests, cultural activities, handiwork fare etc.

Roles and Responsibilities of the 2nd party are the following:


- I. The 2nd party shall receive the students from the 1st party and will offer them the required hospitality and other facilities.
- II. The 2nd party shall give training to the volunteers from the 1st party institution in palliative care and volunteer ship as per the guideline of WHO.
- III. The second party shall assign duties to the volunteers from the 1st party institution and will provide necessary medicines, sanitary materials, medical equipment etc.
- IV. The second party shall arrange transportation and other facilities required to volunteers.
- V. The second party shall issue certificates to students from the first party who discharges the duties assigned to them satisfactorily.
