Scholarship Policy

SCHOLARSHIP POLICY OF MADEENATHUL ULOOM ARABIC COLLEGE

Madeenathul Uloom Arabic College administers two scholarship policies for the benefit of the students of the college, who secure required mark and other eligibility conditions. The students are benefitted with these scholarship schemes according to their eligibility. In addition to the government scholarship, Institution provides freeships, concessions and prizes to eligible students who complete minimum required conditions and procedures.

1. Government Scholarships:

E-GRANTS

Eligibility:

The e grants scholarship has a set of conditions based on current academic qualification, family income, etc., which must be fulfilled to be selected for the scholarship. After meeting the criteria, the candidates can apply for the program within the last date. Given below are the details of the e grantz scholarship eligibility criteria:

- The applicants should be domiciles of Kerala.
- They should be studying at the post-matriculation level from any recognised college/ board
- The applicants should not secure atleast 75% at the end of each month.
- They should have taken admission under the merit and reservation quota.
- Students belonging to the SC/ OBC/ Other Eligible Community [OEC] and other socially/economically backward communities can apply for an e grantz scholarship 2021
- The candidates belonging to SC and OEC categories do not have any annual family income limitations.
- The annual family income for the e grantz scholarship of OBC students should not exceed INR 1,00,000.
- The annual family income of other categories should not exceed INR 1,00,000

The candidates should submit the applications within the e grantz scholarship last date. Eligible candidates can apply online through the official portal.

POST METRIC SCHOLARSHIP

The Prime Minister's New 15 Point Programme for the Welfare of Minorities was announced in June, 2006. It provides that a post-matric scholarship scheme for meritorious students from minority communities would be implemented.

OBJECTIVES:

The objective of the scheme is to award scholarships to meritorious students belonging to economically weaker sections of minority community so as to provide them better opportunities for higher education, increase their rate of attainment in higher education and enhance their employability

ELIGIBILITY:

Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardians from all sources does not exceed Rs.2.00 lakh.

KERALA STATE HIGHER EDUCATION SCHOLARSHIP

The concept of instituting scholarships to meritorious students to pursue higher education was an offshoot of the declared motto of the Kerala State Higher Education Council; that is to bring about equity and excellence in higher education sector. Act 22 of 2007, by which the KSHEC was set up, empowers the council to evolve schemes for providing equitable opportunities for higher education through scholarships and free ships and financial assistance to the needy students.

CH MUHAMMED KOYA SCHOLARSHIP

CH Muhammed Koya Scholarship offered by the Directorate of Minority Welfare (DMW), Government of Kerala. DMW published the online applications for the CH Muhammed Koya Scholarship 2019-20. This Scholarship offered to Girls belonging to the Latin, Muslim or Converted Christians Community for higher education. So that they can pursue higher education without financial hassle. These students should be studying in the first year of the UG courses in any Govt/Aided Institutions.

FISHERIES SCHOLARSHIPS:

Fisheries Scholarship is offered by the Fisheries Department of Kerala for the recognized children of fishermen. The degree students will be granted an amount of Rs.950/- and PG students will receive Rs.1000 apart from the course fee. The application should be submitted to the Head of the Institution which will be forwarded to District Fisheries Director. The form can be had from the Fisheries Department.

PROF.JOSEPH MUNDASSERY SCHOLARSHIP AWARD

This scholarship is offered by the Government of Kerala for the Religious Minority students who fulfills the following conditions

Scholarship Award

Degree: Secured 80% Rs.15,000

PG: Secured 75% Rs.15000

SSLC/Plus Two/VHSE: Full A Plus Rs.10,000

Eligibility

- 1. Should belong to Muslim, Christian, Sikh, Buddha, Parsis, Jain community
- 2. Family Annual income should not exceed 8 Lakhs
- 3. Should passed in Govt/Aided Schools
- 4. Should be a native of Kerala

Candidates must fulfill the following eligibility conditions:

The student must belong to the Muslim, Latin or Converted Christian Community.

Students must be a domicile of Kerala State.

- Students must be a Girl student studying for graduation or higher courses in Govt/Aided
- Students who have given the Common Entrance Examinations and got admission to selffinancing colleges from the merit seat are also eligible.
- Students must have secured at least 50% marks in the qualifying examinations.
- The student's family income should not be more than 8 Lakhs per annum.
- Students who apply for hostel stipend must be staying in recognized hostels.
- Students who are eligible for the hostel stipend will not be eligible for the scholarship.
- Students must have a bank account in any recognized bank to receive the scholarship amount.

2. Institutional Freeships:

1 Al Mabarra Scholarship:

"Almabarra" Scholarship is instituted by the college under the Depaprtment of Islamic Finance with an aim of providing financial assistance to financially backward students and it facilitate loan to those who are in need. The eligibility of the students will be checked by the monitoring authority. The scheme also conducts talent test to the students and prizes and awards are issued to eligible candidates.

2 "Sakan" Hostel Fee Deduction Scheme

"Sakan" Hostel fee deduction scheme is also initiated by the college with an aim of providing financial deduction in the monthly Hostel fee. The eligibility of the scholarship is depends upon different criteria. The marks, financial conditions etc. will be considered for the eligibility

3. Principal's Relief Fund:

The Principal Relief Fund is initiated and administered by college principal personally with an aim of providing financial assistance to financially backward students. The eligibility of the scheme is considered depending upon the academic merit and financial condition.
